With her record label, **Warrior Girl Music**, gilli moon has launched Females On Fire as a vehicle and platform for female artists (now over 65 artists) to be heard and shine, with now two compilations and an ever growing, ongoing, tour.

Promotion and distribution are directed to music supervisors (film and television), music publishers, national music conferences & seminars, record labels, the media (print and radio), producers, and artists looking for songs. The CD is a perfect vehicle for artists to access the music industry, the media and make potential long lasting business relationships for their music. Retail distribution includes direct sales through the Warrior Girl Music Store and our distributors in the U.S, Canada and Australia.

THE CD's mission is to create, promote and manage unique artistic creations guided by the artist's vision and under the artist's direction; creations that transcend race, age or gender and embrace passion, love for music and life, personal excellence and global consciousness.

The album is focused on 4 main elements, which the artists are asked to use as guidelines in their submission:

1. exposure of great talent and timeless songs.
2. a celebration of female fire and femininity.
3. following Warrior Girl Music's mission above.
4. a highly creative and production-strong CD, competitive in the market place.

We also select many of the Females On Fire artists to **perform at Warrior Girl Music events** to promote the CD and the artists involved.

Females On Fire Cd Compilation No.3

Application rules

Warrior Girl Music's team will select the best songs (submissions will be heard by a panel of respected industry consultants), compile the music, professionally master the tracks, design the CD artwork with eye-catching designs, package and press the CDs, and promote to the music markets. The resulting CD is presented as a professional package which will present each artist strongly and favorably. There will be a limit to the number of artists we select. A production fee is required to participate on the CD and third party opportunities can contact artists directly for further opportunities. We encourage you to read our FAQ page on our website for more information about this.

- 1) You must be the songwriter of your song. If you submit a co-written song with another songwriter, they must also AGREE to our application/agreement.
- 2) You must be the solo Master owner of your sound recording.
- 3) Send only *Master quality*, radio friendly tracks on via email in MP3 format (highest quality you can. We use these on the CDs). NO DATS, NO CASSETTES, NO CDS by mail. All submissions must be via email or through our online Sonicbids submission form below.
- 3) All songs must be no longer than 4.20 minutes in length. If it is over 4.20 minutes, we will fade the song at 4.20 minutes in mastering
- 4) You must be willing to be part of a large group of Females On Fire artists, willing to share resources, touring ideas and collaborate. This is a community driven project and requires every artist to be enthusiastic, proactive and sharing.
- 5) It costs \$20 to submit a song for Females On Fire. This covers our admin costs of going through the hundreds of submissions, and selecting artists.
- 6) Once accepted, you agree to pay the production fee - \$400 plus \$20 (for the CDs shipped to you) as outlined on our website under FAQ. If you apply through Sonicbids or directly with a \$20 submission fee, your first \$20 submission fee is taken off the final \$420, so you only pay \$400.
- 7) You must sign our contract to participate in this CD.

Once you sign the contract, and paid the fee, your commitment with us is legally binding.

If you do not agree to the above, then the Females on Fire project is not for you, and that's ok.

Agreement

By completing and submitting this Application Form and Agreement, You acknowledge and agree to the following:

- 1. License Grant.** “You” (the Songwriter(s) and/or Artist(s)) hereby grant to Warrior Girl Music (“WGM”) an irrevocable, perpetual, royalty-free, non-exclusive license to reproduce, manufacture, distribute, perform, market, sell and otherwise exploit the Song(s) throughout the universe (“Territory”) in accordance with the terms and conditions set forth in this Agreement. You hereby authorize WGM to reproduce the Song(s) on a compilation phonorecord containing songs performed by various artists titled *Females on Fire* (“Album”), and to distribute such Album to the public for promotional purposes and retail sale.
- 2. Packaging and Publicity.** You hereby grant to WGM the right to reproduce and otherwise use, in any media whether now known or hereafter created, the name and likeness (including, but not limited to, photographs) of and biographical materials concerning You and all other musicians, artists and songwriters associated with the Song(s) (collectively referred to as “ID Materials”) in connection with the Album and for purposes of advertising, promotion and trade in connection with the making and exploitation of the Album and general goodwill advertising for WGM’s business and products consistent with the terms of this Agreement. You hereby waive any right to inspect or approve any use of Your Song(s) or ID Materials in conjunction with the Album hereunder. You agree that WGM shall have the right, in WGM’s sole discretion, to affix the trademark WARRIOR GIRL MUSIC and other trademarks on or to the Album and on packaging, advertising, and promotional materials used, or distributed in connection with, the Album.
- 3. Compensation.** You understand and agree that, as full compensation for any and all rights granted by You to WGM hereunder, WGM shall provide You with a total of twenty (20) complimentary copies per song you have on the Album, when such Album is completed and released. You may also purchase additional copies of the Album from WGM at wholesale for \$4.00 U.S each. You may sell, at a price to be determined solely by You, or give away any and all Albums given to You by WGM or purchased by You from WGM. WGM agrees that You shall retain any and all profits from any such sales of the Album by You. You understand and agree that WGM shall not pay You, or any other artist(s) and/or songwriter(s), any royalty, fee, or monetary or other compensation, other than as set forth herein, including, but not limited to, mechanical royalties, resulting from the sale or other exploitation of Albums including Your Song(s). You agree that WGM shall retain any and all profits from any such sales of the Album by WGM.
- 4. Copyright Ownership.** Except for the limited rights granted to WGM by You hereunder, You shall retain any and all copyrights in and to the Song(s). You warrant and represent that you have written and/or created original works for the Album; and that no samples were used in the creation of such Master. All communication to WGM by any third party for any future acquisition or use of the Song(s) will be consulted with You. Notwithstanding the foregoing, WGM shall be the sole owner of any and all rights, including, but not limited to, the copyright, in and to the compilation for the Album.
- 5. Copyright Notice.** Each copy of the Album printed pursuant to this Agreement shall carry Your copyright notice as follows: © [year] [Your name]. The Album shall also carry the following copyright notice: © 2007 Warrior Girl Music.
- 6. Website Promotion and Online distribution.** You agree that WGM may post the Song(s) and related ID Material on WGM’s website, www.warriorgirlmusic.com, and affiliate sites for free streaming and downloading including, but not limited to MP3, Windows Media Player or Real Audio format, with no further compensation to You from free downloading sites. You give us permission to offer your song online for digital download, within the contexts only of the Album, and WGM will split net profits 50-50 with You (less distributor fees).
- 7. Representations and Warranties; Indemnification.** You represent and warrant that: (i) You have exclusive or joint copyright ownership in and to the musical composition(s) (“Composition”) and you have exclusive copyright

ownership in and to the master sound recording(s) ("Master") (the Composition and Master shall collectively be referred to in this Agreement as the "Song(s)"); (ii) You have obtained permission or releases from any and all musicians, artists, producers and others performing on the Song(s) to place such Song(s) on the Album, You will make such documents available to WGM upon request, and that WGM shall not be required to pay any such musicians, artists, producers or others for any use of the Song(s); (iii) You own or control any and all rights licensed or granted to WGM hereunder; (iv) the Composition, Master, Song(s) and ID Materials do not violate or infringe any common law or statutory rights, including, but not limited to, copyrights, of any third party; (v) WGM will not be obligated for any payments or incur any liability relating to WGM's use of the Composition, Master and Song(s); and (vi) You have the full right, power and authority to enter into and fully perform Your obligations under this Agreement and to grant and license to WGM all rights as herein provided. You hereby agree to indemnify and hold harmless WGM and its successors and assigns, officers, directors, and employees from and against all actions, claims, suits, proceedings, losses, damages, costs, liabilities, attorneys' fees, and other expenses which may be suffered, incurred, or paid by WGM by reason of, or arising out of, any violation by You of any provision of this Agreement.

8. **Assignment.** You shall not assign or otherwise transfer ownership or interest in this Agreement without WGM's express written consent. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their permitted successors and assigns.

9. **Entire Agreement.** This Agreement constitutes the entire agreement between the parties with regard to the subject matter hereof and shall not be modified except in a writing signed by all parties hereto.

10. **Governing Law.** This Agreement shall be governed under the laws of the State of California.

11. **Relationship of Parties.** The parties to this Agreement are independent of each other and do not intend to create a partnership or joint venture.

12. **Potential Song Placement.** You hereby grant permission (on a non-exclusive basis) to WGM to work out terms on Your behalf with any MTV, movie, film, multi-media, video game, computer game company, third party compilations and/or production group working with such company with regard to potential business opportunities for You. You shall receive 50% of revenues from such use initiated or obtained by Company You agree not to delay or hinder the negotiations between such companies and WGM. However, WGM agrees to consult with You with regard to any negotiations. Artist has final approval on any third party opportunities and negotiations.

13. **Production Fee.** If selected for the Album, You agree to pay the production fee per Song for inclusion on the Album as follows: \$400.00 U.S. ("Production Fee") plus \$20 shipping (waived for Artists applied through Sonicbids). You understand and agree to pay the Production Fee for inclusion on the Album, and you agree that the Production Fee(s) is non-refundable and shall be retained by WGM. If selected, you agree to send us your Mastered radio quality version of your song on CD, clearly labelled with song title and name of artist (without any other songs on the Cd to avoid confusion) no later than 2 weeks after You receive your selection letter.
